

# **ENCINA WASTEWATER AUTHORITY**

The Encina Wastewater Authority (EWA) is a wastewater treatment agency located in North San Diego County, California. Founded in 1961, EWA serves roughly 377,000 residents and regulates approximately 600 businesses in a 123-square mile service area. Six public agencies own EWA through a Joint Powers Agreement that facilitates cost sharing and enables economies of scale that the individual member agencies could not achieve independently. These member agencies are the City of Carlsbad, the City of Vista, the City of Encinitas, the Vallecitos Water District, the Buena Sanitation District, and the Leucadia Wastewater District.

EWA prides itself on being a model of excellence and innovation and has received numerous awards for its leading edge programs. EWA operates and maintains the Joint Sewerage System consisting of the Encina Water Pollution Control Facility (EWPCF), Encina Ocean Outfall, Agua Hedionda Pump Station, and the Buena Vista Pump Station. EWA also manages and operates other regional water recycling and pumping facilities for their owners, including the Carlsbad Water Reclamation Facility, Buena Creek Pump Station, and Raceway Basin Pump Station. In addition, EWA manages an innovative biosolids management program and is a leader in developing renewable energy solutions.

#### **Mission Statement**

As an environmental leader, EWA provides reliable and fiscally responsible wastewater services to the communities we serve while optimizing the use of renewable resources.

#### THE POSITION

Overseeing a combined operating and capital budget of \$43 million and 72 full-time employees, the General Manager provides executive oversight to EWA's Operations, Environmental Compliance, Technical Services, Engineering, and Financial & Administration programs. In addition to guiding internal operations, the General Manager takes an active role in developing and maintaining positive and productive relationships with EWA's member agencies, external organizations, and key stakeholders.

#### **Challenges and Opportunities**

This is an exciting time for EWA! The incoming General Manager will have the opportunity to establish themselves on the strong foundation created by the current incumbent, who is retiring, and chart a course for the future as Encina enters a new era. In the coming months and years, EWA will be expanding its focus to provide a variety of new services and products. It will also be exploring new revenue-generating programs that would help defray ratepayer costs. Below are a few examples:

EWA recently agreed to participate in pilot program which aims to demonstrate the effectiveness of advanced water treatment for potable reuse. Anticipating a positive outcome, staff is developing a Water Reuse Strategic Plan that will include:

- development of a funding strategy
- partner outreach and development of the North County One Water Program
- development of a Regulatory Strategy
- the needs and approach to EWPCF improvements, and
- plan implementation

EWA is also pursuing initiatives to produce RNG fuel through a high strength waste program, evaluate its source control program, inspect its ocean outfall, and implement programs to address climate change.

In addition, EWA has adopted an aggressive Capital Improvement Program and is currently rehabilitating key process infrastructure assets that will provide reliable and cost-effective wastewater treatment services to the communities we serve for years to come. Current projects are in the area of preliminary and primary treatment systems, solids process systems through anerobic digestion and heat drying of biosolids, and secondary and effluent treatment systems. The Authority is also undertaking an effort to standardize, centralize and secure its SCADA system.

The ideal candidate is an energetic, strategic leader who is eager to embrace new challenges while, at the same time, ensuring that EWA continues its tradition of excellence in providing efficient, cost-effective service. They have an entrepreneurial spirit and possess good management skills. They are results-oriented yet flexible. They personify integrity, build trust, and have excellent communication skills. They understand the important role that each one of their members plays in contributing to the overall success of the organization and advocate complete transparency. They maintain positive, productive partnerships.

They are supportive and encourage professional growth and development. They provide clear direction and stick by their decisions. They understand the evolution of the workforce and are open to new approaches to conducting business.
